Mahoning County Public Health is presenting a course designed for artists and operators of tattoo and body piercing establishments to provide training in safety and sanitation applicable to the prevention of disease transmission, first aid and aftercare, standard precautions against bloodborne pathogens and the regulations enforceable by local public health agencies. This course is designed to satisfy the requirements of rule 3701-9-04 (M)(2) & (3) of the Ohio Administrative Code for artists and operators practicing in Mahoning County, Ohio.

A non-refundable fee of \$75 per person, made payable by check or money order to Mahoning County Public Health, must be received prior to Monday, April 6, 2026. Persons who have previously completed this course and wish to re-attend may do so at a reduced cost of \$25 per person.
